PARENTAL RESPONSIBILITY AND COMMITMENT

- Provide your child with a suitable instrument after the term of the loan.
- Agree to pay the **\$40** Instrumental Music Levy.
- Maintain an interest in your child's music study.
- Arrange a regular time and a suitable place for playing. Help with playing where possible.
- Provide a safe place to store the instrument, and keep the instrument in good repair.
- Encourage your child with positive support to be punctual for lessons, ensemble rehearsals and performances.

STUDENT RESPONSIBILITY AND COMMITMENT

- Attend all lessons, rehearsals and other classes as required.
- Practice regularly at home, at least 20 minutes per day, 5 times per week.
- Develop a supportive attitude to other students in lessons and ensembles.
- Take all due care and responsibility for school instruments and property.
- Become a member of one of the school ensembles as designated by instructor.
- Participate in the instrumental music program including all concerts and workshops for a minimum a **one-year** period.

GENERAL INFORMATION

- Students must attend all lessons and rehearsals. Lateness and absences must be explained in a letter to the Instrumental Music Teacher. Unexplained absences will be noted. Lessons may be terminated by removing your child from the program after forwarding a note to this effect, or by the Principal who, after consultation with the teachers involved, may exclude any child who fails to make steady progress or fails to attend rehearsals and scheduled performances.
- Enrolment is for a minimum of a **one-year** period.
- Tuition is free of charge, however a non-refundable levy of \$40 per student, per annum is charged to assist in the development of the music program. An additional \$100 is charged, per annum, for rental of a school instrument.
- If you are hiring an instrument you **MUST PAY THE \$100 LEVY** before you will be able to take the instrument home.
